- Field 98 DISTRICT ENTRY DATE Definition update If a student withdraws from the LEA then returns, the date of the student's re-enrollment in the LEA.

 - Incident number used by local law enforcement to identify the incident
- NEW Field 17- INCIDENT REPORTER TYPE CODE
 - Indicator that identifies whether the incident was reported through the Safe2Say hotline program
- NEW Field 24 UNFOUNDED INDICATOR Y/N indicator that identifies a reported incident that was investigated by law enforcement and determined to be unfounded

INCIDENT OFFENDER TEMPLATE:

 NEW Field 22 – PRIMARY PLACEMENT TYPE – Y/N indicator that identifies is at the time of incident, was the student placed in a residential facility or group home in the same state by a non-educational agency (REQUIRED if Incident Offender Field 5 OFFENDER TYPE = 2 – Student with IEP)

INCIDENT OFFENDER INFRACTION TEMPLATE:

- Field 6 WEAPON COUNT Updated required if Field 4 (INFRACTION CODE) is
 54 (removed between 39 and 46)
- Field 7 INFRACTION COMMENT Updated required if INFACTION CODE = 16 (removed 41 or 46)
